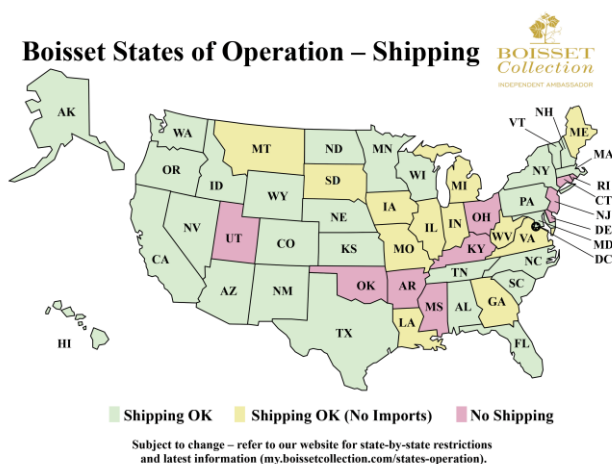


# STATES OF OPERATION

The Boisset Collection Ambassador Program is part of the Boisset Collection family, headquartered in St. Helena, CA. The Boisset Ambassador Program is a direct-to-consumer marketing program offered through a network of independent Wine Ambassadors (independent agents) for Boisset Collection.

Our Wine Ambassadors are marketing agents and do not sell or carry wine inventory for sale. All wine orders, including tasting flights, are shipped directly from our licensed wineries (Buena Vista Winery, DeLoach Vineyards, JCB Wines, Raymond Vineyards, Wattle Creek Winery) or our authorized shipping companies.

Each state has different laws pertaining to the direct shipment of wine to consumers. Below is the list of our current state of operations and the applicable limitations by state in volume, which is subject to change without notice. 	Direct Shipping Volume & Limitations By State
Alabama	Must be shipped to a state liquor store. ABC form must be included on each order
Alaska	No Ground shipping available; orders must be shipped via 2 Day Air or Overnight
Arizona	6 cases per individual per year
California	No Limitation
Colorado	No Limitation
Florida	No Limitation except 10L bags
Georgia	12 cases per year (Date of Birth required on all orders). Shipping of "Imported" wines is prohibited
Hawaii	6 cases per household per year. No Ground shipping available; orders must be shipped via 2 Day Air or Overnight
Idaho	2 cases per individual per shipment/24 cases per individual per year
Illinois	12 cases per individual per year. Shipping of "Imported" wines is prohibited

Indiana	Can only ship Buena Vista, DeLoach, JCB, Lockwood, Lyeth and Wattle Creek wines. Shipping of Raymond, Frenchie, LVE or "Imported" wines is prohibited.
Iowa	2 cases per individual per year. Shipping of "Imported" wines is prohibited
Kansas	12 cases per individual per year (Date of Birth required on all orders)
Louisiana	Boisset cannot ship any wines that are in distribution in this state. Please contact your Ambassador or <a href="mailto:customer@boisset.com">customer@boisset.com</a> for assistance with your order.
Maine	12 cases per household per year. Shipping of "Imported" wines is prohibited
Maryland	18 cases per household per year
Massachusetts	12 cases per individual per year
Michigan	DOB required on all orders. Shipping of "Imported" wines is prohibited
Minnesota	2 cases per individual per year
Missouri	2 cases per individual per month. Shipping of "Imported" wines is prohibited
Montana	18 cases per individual per year. Shipping of "Imported" wines is prohibited
Nebraska	1 case per individual per month
Nevada	12 cases per individual per year
New Hampshire	5 cases per household per year; no shipping to Ellsworth or Monroe
New Mexico	2 cases per individual per month
New York	36 cases per individual per year
North Carolina	2 cases per individual per month
North Dakota	3 cases per individual per month
Oregon	2 cases per individual per month
Pennsylvania	36 cases per individual per year
South Carolina	2 cases per individual per month
Tennessee	1 case per individual per month/3 cases per year per individual
Texas	3 cases per individual per month/15 cases per individual per year
Vermont	12 cases per individual per year. Orders must be shipped via FedEx
Virginia	2 cases per individual per month. Shipping of "Imported" wines is prohibited
Washington	No Limitation
Washington, D.C.	1 case per individual per month
West Virginia	Can only ship Buena Vista, DeLoach, Frenchie, JCB, LVE, Raymond and Wattle Creek wines. Shipping of any other brands or "Imported" wines is prohibited
Wisconsin	12 cases per individual per year (Date of Birth required on all orders)
Wyoming	2 cases per household per year; no 10L bags
